

**New College Student Alliance**  
**Acknowledgment, Waiver and Release Agreement**

The New College Student Alliance (NCSA) sponsors a Music Room in Hamilton Center on the campus of New College of Florida. The NCSA provides the space so that students can have a place to practice and to store musical instruments. I am executing this Agreement in consideration for using the NCSA sponsored Music Room.

I desire to use the Music Room. I understand that participants in the activities of NCSA are required to take direction from the NCSA and from New College of Florida staff or their agents or designees. I agree to take direction from NCSA officers and from New College of Florida staff or their agents or designees in connection with use of the Music Room.

I acknowledge that I am familiar, and will take responsibility for complying with the New College of Florida Student Judicial Code of Conduct at all times while I am participating in the activities of the NCSA, including use of the Music Room.

I understand and acknowledge that failure to comply with the New College of Florida Judicial Code may, in the sole discretion of the NCSA or New College of Florida staff, agents or designees, disqualify me from further participation in the activities of the NCSA, including use of the Music Room.

I understand that there is a risk that equipment that I store in the Music Room may be lost or stolen. I take full responsibility and assume the risk of loss or damage to any equipment that I store in the Music Room. **I hereby release the State of Florida, the Florida Board of Governors, New College of Florida, the New College of Florida Board of Trustees, and the NCSA, their agents, officers, members and employees, from any and all liability for any actions, causes of action, damages, claims or demands which I may have for any loss of property I incur on account of using or storing equipment in the Music Room.**

I agree not to use musical instruments or other equipment that is stored in the Music Room without the express permission of the owner. I hereby acknowledge that I am responsible for any injuries to persons or equipment that may be incurred in connection with my use of the Music Room. I further realize that I am **not** under direct supervision while using the Music Room. **I hereby agree to indemnify and save and hold harmless the State of Florida, the Florida Board of Governors, New College of Florida, the New College of Florida Board of Trustees, and the NCSA, their agents, officers, members and employees, from any and all loss, liability, damage, or costs that they may incur due to my use of the Music Room.**

I understand that I am responsible for the key to the Music Room while it is in my possession. After using the Music Room, I am responsible for locking the room and returning the key to the New College of Florida Police Department. I may not keep the key overnight.

I agree that this Agreement is intended to be as broad and inclusive as is permitted by the laws of the State of Florida, and that if any portion of this Agreement is held invalid, the balance, shall continue in full legal force and effect.

I am at least eighteen (18) years of age. I have read and understand this Agreement. I execute it voluntarily and with full knowledge and comprehension of its meaning and significance.
